Pivot Bio's Ultimate Farm Truck Giveaway Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT DOES NOT IMPROVE YOUR CHANCE OF WINNING.

1. **Eligibility:** The Pivot Bio's Ultimate Farm Truck Giveaway (the "Promotion") is open only to eligible participants who meet all the following criteria:
 - a. You must be an individual who is a commercial grower (farmer) who actively and materially participates in a commercial grain/cereal row crop farm operation of at least 250 acres (i.e., an individual with rights and authority, through direct ownership or contract, to operate, control, and manage the farmland, employees of a commercial grower or those working other supporting roles who do not have a controlling interest in the farmland are not eligible);
 - b. You must be a legal resident of the 48 contiguous United States or the District of Columbia (the "Territory");
 - c. You must have reached the legal age of majority in your state of residence
 - d. You must be located in the Territory at the time of entry.

Pivot Bio ("Sponsor"), SweepstakesPros ("Promotion Administrator"), AKC Marketing and their respective parent companies, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, judging and promotion agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, "Promotion Parties"), and members of their immediate families (defined as including spouse, biological, adoptive and step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) or households (whether related or not) of any of the above are not eligible to participate. Follow the on-screen directions, complete all required fields and submit to enter (an "Online Entry") to receive one (1) entry in the Promotion. Entrants must complete all required information. LIMIT ONE (1) ONLINE ENTRY PER PERSON/EMAIL ADDRESS/PER DAY. To the maximum extent permitted by law, all entries become the exclusive property of the Sponsor and will not be acknowledged or returned except as provided herein. You are not a winner until your prize claim is validated and you receive official written notification from the Sponsor or the Promotion Administrator.

5. **Semi-Finalist Prize Drawing:** On or about October 7, 2022, in Saratoga, California, the Promotion Administrator will conduct a random drawing from among all eligible entries received during the entire Promotion Period for fourteen (14) “Semi-Finalists”, two (2) Semi-Finalists will be selected from each Sales Territory, from among all eligible entries received during the entire Promotion Period.

Failure to provide such proof to the complete satisfaction of the Promotion Administrator within the timeline specified by the Promotion Administrator may result in disqualification by the Promotion Administrator, in its sole discretion.

17. **Choice of Law, Jurisdiction and Notice:** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.
