### SECTION 4: FIRST AID MEASURES

### SECTION 6: ACCIDENTAL RELEASE MEASURES

**Methods for cleaning up:** Wear gloves and cover the spill area with absorbent towel. Pour liquid disinfectant, such as freshly prepared 10% bleach solution, over the covered spill area allowing it to mix with spilled material for 10 minutes. Using scoops or cardboard, scoop up the material and discard it into waste container for disposal into municipal waste. Clean contaminated floors and surfaces thoroughly with water and detergents, observing environmental regulations. Remove gloves and wash hands with clean water and soap.
